

Soft Kitty Cattery guarantees that the kitten named below is:

- from parents not carrying either the HCM or PKD gene
- has been given a broad spectrum anti-worm medication prior to pick up/shipping
- has been vet checked
- has their first FVRCP shot
- has had a flea topical prior to departing for their new home

A copy of the kitten's health record will be given to the buyer at the time of purchase. Soft Kitty Cattery cannot warranty a kitten against any adverse reactions to future vaccinations.

If your kitten is shipped, please be aware that there is the possibility for your kitten to pick up a few fleas on the flight. This would be a unlikely occurrence, but the kitten could be in close quarters with animals who's hygiene is not under our control. As all kittens are treated for fleas, any on them should die.

We suggest keeping the kitten in a private area away from other pets until it is checked by your vet.

The kitten must be taken in for an exam at a licensed veterinarian of the new owners choice within 7 business days. We suggest setting an appointment up in advance when you know the date of your kittens pick up/arrival. A dated copy of your veterinarian's health assessment must be received by Soft Kitty Cattery within 10 days of receiving your kitten or this guarantee will be void.

Should the exam reveal the kitten to have a serious inborn defect, disease, condition, or illness, a official signed statement by the veterinarian on his or her letterhead identifying the problem must be given to Soft Kitty Cattery within the 10 days of the diagnosis. The kitten may then be returned with in 10 days to the cattery at the buyer's expense and will be replaced with the first available kitten of similar quality.

Buyer is responsible for all vet related expenses once the kitten is released from Soft Kitty Cattery. This includes initial exam, office visits, lab tests, vaccinations, medications, surgery, or time off work.

If the below named kitten dies within two years of the date of purchase

due to hereditary or congenital defects, or a qualified veterinary examination finds the purchased kitten to be medically deficient with an untreatable or life threatening congenital defect Soft Kitty Cattery will replace the cat or kitten with one of similar quality. We do not offer cash refunds. To determine if the cat's death has been caused by a congenital or hereditary defect, Soft Kitty Cattery must receive proof of the defect in the form of a complete necropsy report or written statement in regards to the diagnosis of the kitten's condition, completed by a licensed veterinarian. Soft Kitty Cattery is not responsible for costs relating to the necropsy. If after reviewing the findings it is determined the death was under warranty, a replacement kitten of equal value would be offered as soon as possible.

Failure to have the kitten examined by a veterinarian within the stated amount of time, declawing, or any evidence of abuse, neglect, or mishandling voids the contract.

It is agreed that this is an "As Is" sale, subject only to the warranties outlined herein which is the final agreement of all parties. By signing below, you acknowledge that you have read this contract in its entirety and agree to all of its requirements, stipulations and terms thereof, and that you have received a copy of this contract for your records.
